**Subject: Purchase of treasury shares**

Legal basis: Article 56 Section 1 Item 2 of the Public Offering Act - current and periodic information

### Contents of the report:

MAKRUM S.A. with offices in Bydgoszcz (Company) notifies that, as part of the programme consisting in repurchase of treasury shares for the purpose of their further resale (Programme), on 25 March 2013 the Company purchased 9 571 (nine thousand five hundred seventy one) shares of MAKRUM S.A. for a price of PLN 1.2904 for each (one) share.

Accession to the Programme was communicated by the Company in the current report Rb no. 66/2012 dated 5/10/12 and Rb no. 70/2012 dated 11/10/12.

Treasury shares are purchased by the Company via Dom Maklerski Banku BPS S. A. (BPS Bank Brokerage House) under „Agreement for handling purchase of treasury shares” (Rb no. 67/2012 dated 8/10/12).

Nominal value of shares is PLN 0.25. Purchased shares amount to 0.013 % of the share in MAKRUM’s share capital and correspond to 9 571 votes at the General Meeting.

As of today, MAKRUM Group holds 521 453 treasury shares corresponding to 521 453 votes at the General Meeting of Shareholders, which is 0.71% of all shares – as per the below statement:

- MAKRUM S.A.: 97 187 shares,
- IMMOBILE Sp. z o.o.: 324 266 shares,
- CDI Konsultanci Budowlani Sp. z o.o.: 100 000 shares.
